Key Information Document

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

This product is a Stocks and Shares Flexible Individual Savings Account provided by Unity Mutual.

We are supervised by the Financial Conduct Authority (FCA) in respect of the production and delivery of this Key Information Document (KID).

What is this product?

Objectives: The Unity Mutual Stocks & Shares Flexible ISA (ISA) is an insurance based ISA. It allows investments to be made into the Unity Mutual Equity Fund, subject to qualifying conditions laid down by H.M. Revenue and Customs (HMRC) regulations.

The proceeds of the investment will be free from Income and Capital Gains taxes under current HMRC ISA regulations.

The Unity Mutual Flexible ISA aims to:

- provide an easy tax efficient method of investing your money;
- provide the flexibility of making withdrawals without losing any tax-free allowance; and
- maximise mid to long-term capital growth by investing in stocks and shares.

Where is the money invested: The money is invested in the Unity Mutual Equity Fund. The investment objective of this Fund is to track the capital performance of the UK stock market by investing in over 600 UK companies. As the Fund's investments are spread across a wide range of companies, the risk of it being affected by a single underperforming company or sector is reduced.

The contributions you pay are used to purchase units in the Fund. The investment performance of the Fund will determine the value of your ISA.

The value can go down as well as up and the proceeds will depend on the investment performance of the Fund, which cannot be predicted. Growth cannot be guaranteed, and you may receive back less than the amount paid in and the amount illustrated at the outset.

How can the performance be tracked: A statement will be issued annually which will show the value of your ISA plan, or you can also contact us at any time to ask for a valuation.

Intended retail investor: The Flexible ISA is available to anyone aged 18 or over, and is resident in the UK, or a Crown employee (or their spouse/civil partner) working overseas.

You cannot hold an ISA with, or on behalf, of someone else.

How much can you invest: You can make contributions into this ISA up to the HMRC ISA contribution limit in each tax year. The current limit can be found at **https://www.unitymutual.co.uk/customercentre/contribution-limits/**. However, if you have more than one type of ISA the limit applies to all contributions. It is anticipated that this limit will increase each year in line with Inflation.


The minimum contribution is £25 per month or an initial lump sum of £250, and contributions can be stopped or changed at any time without penalty.

Insurance benefits: If you should die 101% of the value of your ISA on the date of death will be paid to your estate.

Recommendation: You should aim to invest for no less than five years as an investment of less than five years may not return any real growth. You should bear in mind that over the mid to long term (5-10 years and over), inflation is likely to erode the purchasing power of your investment.

What are the risks and what could I get in return?

Risk indicator





The summary risk indicator (SRI) assumes you keep the plan for 10 years. The actual risk can vary significantly if you cash in at the early stage and you may get back less.

- We have classified this account as 4 out of 7, which is "medium" risk class. This rates potential losses from future performance at a medium level.
- The risk category is not guaranteed and may shift over time.
- On closing your Flexible ISA you would receive the current value of units. On death, you would receive 101% of the current value of units.
- The risk indicator is based on historical data and may not be relied upon to gauge the future risk profile of the product.

What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown below are the cumulative costs of the product itself, for three different holding periods. The figures assume you invest a £10,000 single premium. The figures are estimates and may change in the future.

How long should I hold it and can I take money out early?

The money in your Flexible ISA can be withdrawn at any time, however if your investment is for less than five years you may not return any real growth.

Under HMRC flexibility rules you can take money out of your ISA and replace it, in whole or in part, in the same tax-year without the replacement counting towards their annual subscription limit. For example, if you have £20,000 in your ISA including £5,000 deposited in the current tax year, you can withdraw £10,000, and then invest a further £25,000 in the tax year: the £10,000 you took out, plus the remaining £15,000 allowance.

Can I change my mind?

Following receipt of your application you will be given 30 days in which to change your mind, at which point a full refund of any contributions paid will be refunded. Please refer to section 7 of the Flexible ISA Terms & Conditions for more information.
